This information is garnered from you directly, a third party on your behalf, or through your interaction with our services, website (www.Abetglobal.com), and related platforms, including the Company's Members Area. Additionally, the Privacy Policy outlines your entitlements concerning the processing of your data.

We routinely review our Privacy Policy to ensure its alignment with new obligations, technological advancements, changes in business practices, and adherence to evolving regulatory landscapes. The most recent iteration of our Privacy Policy will govern any personal information in our possession.

Upholding Information Confidentiality and Preserving Privacy

The Company extends its respect for privacy to all users who engage with its website(s), vowing to take reasonable measures to safeguard the interests of existing or prospective clients, applicants, and website visitors.

In alignment with applicable data protection laws and regulations, the Company adheres to the proper storage of personal data belonging to clients and potential clients.

We have implemented comprehensive technical and organizational measures to guarantee the continuous security of your data. Regular training sessions ensure our employees understand the importance of upholding and respecting your personal information and privacy.

Instances of privacy breaches are treated with the utmost seriousness, and appropriate disciplinary actions, including dismissal, are taken when necessary. The personal information you furnish during your registration on the Company's website or for its services is categorized as registered information and is fortified through various protective measures. Access to your registered information in the Members Area is granted via a personal username and password, which you should ensure remains confidential. VII. Authentication data (e.g., signature).

VIII. Location information.

IX. Trading performance and experience.

X. Verification details: passport, driver's license, identification numbers.

XI. Information to identify you and enhance your trading experience.

XII. Website activity and movement.

XIII. This data is gathered through various channels, such as websites, apps, demo sign-ups, webinars, and customer service communications. Third-party sources may also provide relevant information. Your trading behavior, including product preferences and trading history, is maintained.

XIV. Trade products and performance.

XV. Historical investment data.

XVI. Product and service preferences.

XVII. Occasional collection of personal information (e.g., surveys).

XVIII. Non-provision of requested information might hinder product/service fulfillment.

XIX. Communications (phone, electronic, in-person) may be recorded for evidence.

XX. CCTV recordings might be present at our premises.

XXI. Unsolicited personal information is securely discarded if unnecessary for our services. Feel free to reach out to us if you need further assistance.

Job Applicant:

For job applicants, personal information is meticulously stored within the Company's personnel records and Human Resources systems. Exclusive non-disclosure agreements tailored for employees are provided upon recruitment.

The Company may hold various types of data relevant to individuals, including:

2. Adhering to Legal Requirements

Our operations are subject to various legal and regulatory obligations, encompassing anti-money laundering, financial services, and corporation, privacy, and tax laws. We also comply with supervisory authorities such as the SVG. To meet these requirements, we engage in personal data processing activities for purposes such as credit assessments, identity validation, payment processing, court order compliance, tax reporting, and anti-money laundering protocols. These obligations arise during client onboarding, payments, and systemic risk assessments.

3. Protecting Legitimate Interests

We process personal data to safeguard our or third-party legitimate interests, ensuring business and commercial viability without compromising ethical considerations. This processing aligns with a valid business or commercial rationale while respecting your rights and interests. Examples include:

I. Initiating and defending legal claims;

II. Enhancing IT and system security, crime prevention, asset protection, access controls, and anti-trespassing measures;

III. Implementing CCTV systems for premises security;

IV. Enhancing business operations and innovating products and services;

We may process your data based on your consent unless otherwise indicated in this policy. You retain the right to revoke consent, with any prior processing remaining unaffected.

Upon successful account creation or subscribing to updates or webinars, we utilize your personal information to fulfill our service obligations and meet your needs. Continuously striving for excellence, we periodically assess your requirements to ensure our offerings remain beneficial to you.

7. Enhancing Services and Innovation

We may employ the personal information you provide or survey responses to refine our products and services. This aligns with our commitment to deliver outstanding quality and maintain a leading position in the financial services sector. Visitor behavior on our website is tracked to offer efficient support, ensuring a seamless experience.

8. Profiling for Improvement

Your personal information, furnished through service usage or surveys, may be used to enhance our products and services. 9. Addressing Inquiries and Disputes

10. Compliance with Legal Mandates and Orders

We may utilize your personal information to adhere to applicable laws, court orders, judicial processes, or regulatory requirements. This action is not only a fulfillment of legal obligations but is also in line with our legitimate interest.

11. Soliciting Surveys for Feedback

Periodically, we may request your participation in surveys as part of our customer feedback process. Seeking such feedback is in our legitimate interest to maintain exceptional service standards. Occasionally, you might be invited to participate in additional surveys, with your consent guiding the use of collected personal data. Communications related to provided services, products, and our relationship with you are included. Additionally, records are maintained to ensure contractual compliance.

15. Legal Notifications

16. Corporate Restructuring

Disclosure of Your Personal Information

Your personal and confidential information remains safeguarded by the Company, refraining from divulging it to external parties except under specific circumstances:

- b. If there's a public duty necessitating disclosure.

c. When legitimate business interests dictate disclosure.

d. Upon your request, consent, or to individuals specified in this policy. The Company aims to share such information on a 'need-to-know' basis, following regulatory guidance. In such cases, the third party is informed about the confidential nature of the information.

In pursuit of the purposes outlined above, the Company may share your data with the following entities:

I. Members of the ABET GLOBAL Group, including ultimate holding companies and their subsidiaries.





II. Our associates and service providers, are engaged for administrative, financial, legal, tax, compliance, insurance, research, or other purposes.

III. Business introducers with mutual affiliations.

IV. Business parties, credit providers, courts, tribunals, and regulatory authorities as required by law.

V. Payment service providers (PSPs) and banking institutions for deposit/withdrawal issues or investigations.

VI. Individuals authorized by you.

VII. When disclosed to business parties such as card processing companies or banks, they may store your information to fulfill their obligations.

VIII. External organizations handling personal data acknowledge its confidentiality, respect privacy rights, and adhere to relevant data protection laws. Third-party service providers like credit referencing agencies may record searches conducted and assist other companies in their searches. Please note that this Privacy Policy doesn't extend to external third parties acting as data controllers. Their use of your personal information is outside our privacy standards.

Clients acknowledge and consent to the occasional analysis of collected data for statistical enhancement, gathered via website visits or other means, to enhance business activities. Transfers Beyond the European Economic Area (EEA)

Personal information may be transferred within or outside the European Economic Area to other ABET GLOBAL entities and service providers (Processors).

For transfers beyond the EEA, we ensure legality and Processor compliance with European data protection laws or comparable laws of other countries. Adequate safeguards are established in line with GDPR Article 46.

Transfers to Processors in the USA

In specific instances, when transferring data to processors in the USA, we may rely on standard contractual clauses, binding corporate rules, or equivalent safeguarding arrangements that align with applicable regulations.

In light of the above, your data may be processed by ABET GLOBAL staff operating inside or outside the EEA, working for us, other ABET GLOBAL entities, or service providers. These staff members play roles like addressing your requests, managing payment details, and offering support services. Verification documents for activating trading accounts are transmitted over secure connections and stored safely.

Cookies

Internet cookies, and small data pieces stored on your computer, enhance your experience and may include a unique identifier. This data collection aims to personalize web pages. To disable cookie acceptance, adjust your browser preferences. Note that disabling cookies may limit access to specific parts of our website(s).





We also use cookies for re-marketing, allowing ads to target users who previously visited our site(s). Third parties like Google and Ad Roll may be involved in these efforts.

Consent Acquisition

Your Rights Regarding Personal Information

You have rights concerning your data:

Information and Access

Upon request, we confirm processing and provide a copy of your data within 30 days. Additional copies might incur a fee.

Rectification of Personal Information

Ensuring accuracy is paramount to us. We take reasonable measures to maintain your personal information's accuracy, completeness, and currency. If any of your personal information held by us is incorrect or incomplete, you have the right to request its rectification.

If we've shared your personal information with others, we'll notify them of the rectification whenever possible. Upon request, we'll also inform you about the recipients of your information, enabling direct contact.

To update your details, simply email us at support@abetglobal.com. We'll process changes according to your instructions. In some cases, we might require supporting documents from you, particularly for data we must retain per regulatory or legal mandates.

Erasure of Personal Information

In specific scenarios, such as no longer needing your data or your withdrawal of consent (if applicable), you can request the deletion or removal of your personal information. However, this request will be subject to retention limits mandated by laws and regulations, as outlined in the 'Storage of Your Personal Information and Retention Period' section.

If your personal information has been shared with others, we'll endeavor to inform them of the erasure. Upon your request, and if possible and lawful, we'll also provide details of the recipients so you can contact them directly.

Processing Restrictions

Under certain circumstances, like contesting the accuracy of your data or objecting to its processing, you can ask us to restrict its processing. However, this won't hinder us from storing the data. We'll notify you before declining any requested restriction. If your data has been shared with others, we'll communicate the restriction if feasible. Upon your request, and if possible and lawful, we'll also provide information about recipients for direct contact.

Data Portability

As per the General Data Protection Regulation (679/2016), you hold the right, in specific situations, to obtain your provided personal information (in a structured, machine-readable format) for reuse elsewhere or to transfer it to a chosen third party.

Objection to Processing

You can request the cessation of processing your personal information in various scenarios:

- 1. When relying on our or others' legitimate interests, unless compelling legal grounds justify the processing.
- 2. For direct marketing purposes.
- 3. For research, unless deemed necessary for a public interest task (such as regulatory enforcement).





Automated Decision-Making and Profiling

If a decision about you is solely based on automated processing, impacting your service use or other significant aspects, you can request not to be subject to such decisions. However, if such decisions are necessary for a contract between us, you may request human intervention. Please note that opting for this may lead to the termination of our relationship
